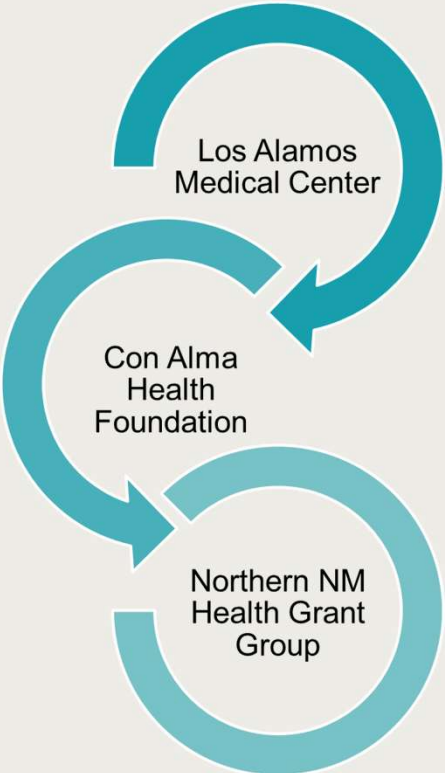
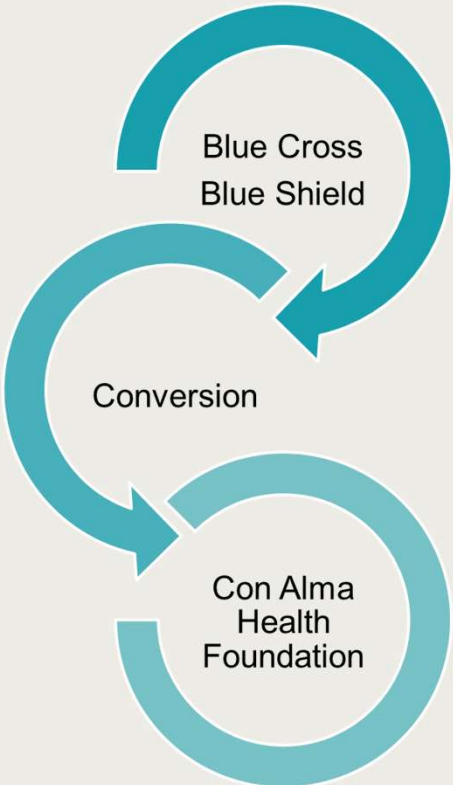



Eligibility Criteria

The Foundation supports requests that have the potential to benefit many members in a system, network, or community (vs. individual needs).

Multi-Year Grants: Larger systemic change concentrating on Policy, Advocacy and Capacity Building.



Eligibility Criteria

Tax-exempt, nonprofit 501(c)(3), or have a fiscal sponsor

Current and past grant recipients may apply

Must benefit people living in New Mexico

If work is to be completed in a tribal area, applying organizations must get a tribal letter of support for the full application.

Multi-Year Grants - Organizations applying must be able to demonstrate 3 years of successful programming.



Eligibility Criteria

Applying Through a Fiscal Sponsor

Projects, non-profits, public or governmental agency or a federally recognized tribe in the state of New Mexico without IRS 501(c)(3) designation may apply through a fiscal sponsor.

If using a fiscal sponsor, the organization serving as fiscal sponsor must have verifiable 501(c)(3) status from the IRS and complete a profile in CAHF's grant portal.

Multi-Year Grants - Organizations applying must still be able to demonstrate 3 years of successful programming.



Eligibility Criteria

Priority Communities

Marginalized because of race, language, gender, disability, sexual orientation, or spiritual beliefs

Immigrant, rural, and border communities

Low-income and economically under-resourced communities

People suffering from chronic health conditions and trauma-related health inequities

People who are uninsured, underinsured, and/or medically underserved



Use of Funds / Allowable Costs

Grants of up to \$50,000 each year for 3 years

Funds may be used for personnel (staffing/benefits), professional services (contractors, evaluators), operational expenses (supplies, printing, postage, copying, communications), meetings and travel (venue rental, training costs), and other direct and indirect expenses.

Purchases of property or equipment are limited to \$5,000 per item.

Multi-Year Grants – No budget required with LOI submission.



Exclusions/Restrictions

Political campaigns, political lobbying, or other partisan activities prohibited by section 501(c)(3) of the Internal Revenue Code

Support to individuals, scholarships, or fellowships

Capital or endowment campaigns, annual fundraising campaigns, event sponsorships, debt liquidation, or clinical research

Grants to organizations that discriminate based on race, ancestry, national or ethnic origin, disability, sex, age, religion, sexual orientation, or gender identity

Grants made for religious purposes

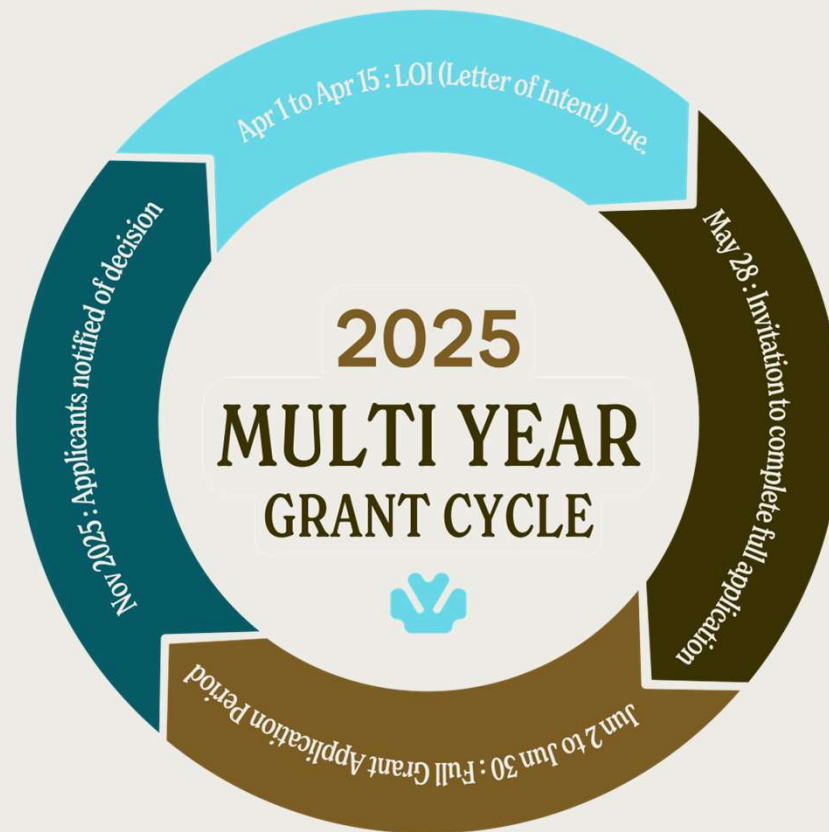
Grants for construction, renovation, or repairs





Multi-Year Grant Cycle

Grant Implementation Period - January to December for up to 3 years



Multi-Year Grant Request Amounts

Applicants may request

\$30,000 Yearly
(\$90,000)

\$40,000 Yearly
(\$120,000)

\$50,000 Yearly
(\$150,000)

CAHF anticipates funding 6-8 grants this cycle.



LOI Questions & Evaluation Rubric

Letters of Intent are limited to 600 words to answer six questions

LOI Questions

Tell us about your organization and the work that you do.

What project are you proposing?

Who will benefit from this funding?

Where do they live?

What long-term changes do you expect with this project?

How does your project align with one of Con Alma's priority areas?



Evaluation Rubric

How well does the organization demonstrate competence and a good track record?

How well does the proposal address root causes or underlying issues that affect health equity?

How well does this serve under-resourced or marginalized people?

How well does this project reach an under-resourced geographic area?

How likely is the work described to make a long-term difference?

How well do the proposed outcomes align with one of Con Alma's priority areas?

Letter of Intent Review Process



Successful organizations will be invited to complete a full application and will be notified by May 28th.


